October 31, 2005

President Richards called the meeting to order at 8:35 A.M.

Julia Halevy and Mary Martin were welcomed to the Board.

The minutes of the April 8, 2005 were unanimously.

Graduate School Issues:

Harry began the meeting by asking Executive Committee members about the most pressing issues they were facing. Issues identified included graduate program reviews, graduate student support, graduate student health insurance, student information system implementation, graduate dean's leadership in accreditation review, development of interdisciplinary programs, financing masters-level education, collective bargaining and faculty workload, strategic planning, assessing graduate student outcomes, supporting doctoral students through entire period of study, and budgeting using responsibility centered management.

Membership Report:

Secretary-Treasurer Scott Delcourt reported that the NAGS membership mailing had recently been mailed. A membership report will be given at the December NAGS Executive Committee meeting. There was a discussion about various ways to increase membership including having a NAGS reception at the CGS conference, better publicizing NAGS award winners on the website, and contacting NAGS institutions via e-mail to obtain feedback on the conference agenda. Gwen and Marty will also promote the NAGS conference at the CAGS annual meeting.

Treasurer's Report:

Scott Delcourt distributed a financial report on the 2005 annual meeting. Revenues for the annual meeting were \$17,060.00; expenses were \$18,581.65 for a small loss of \$1,521.65. Scott noted that this has usually been the case, but that there was a possibility of getting as many as 5 conference sponsors for the 2006 annual meeting, which would improve the revenue.

Awards Committees:

The Executive Committee reviewed the guidelines for the four awards and discussed the committee selection process. Jake Kilmarx who had served several times on the master's thesis committee was nominated to chair the committee this year. After confirming his willingness to serve, the Committee approved Dr. Kilmarx as the chair. The complete list of awards committee chairs is as follows:

Nomination materials will be sent out electronically and in hard copy in mid-November. The deadline for submission of materials for all awards will be February 1. All nomination submissions must be done electronically.

Discussion of the Meeting Program:

The Board brainstormed regarding potential topics for the 2006 annual meeting. Those topics identified included:

There was also some discussion of changing the length and days in which the annual meeting is held and altering the scheduled times for plenary sessions in order to add a couple brief sessions, including an update from the CGS staff. Harry announced that he would ask UNH President Ann Hart to be the keynote speaker.

The Board decided upon a nautical conference theme for Portsmouth: "New Wine in Old Bottles: Navigating Advances in Graduate School".

An evaluation form will be included in the conference folders to collect feedback from participants.
